### Management Update

- We had 14 services in Shafter and 7 services in Wasco for the month of October 2023. • This gives us 100 services for the fiscal year to date. We have had 23 cremation services in Shafter and 5 in Wasco for a total of 28 cremation services. We are at a 28% cremation rate.
- We had 8 services in Shafter and 11 services in Wasco for the month of November 2023. ٠ This gives us 119 services for the fiscal year to date. We have had 24 cremation services in Shafter and 6 in Wasco for a total of 30 cremation services. We are at a 25% cremation rate.
- California Resources Corporation has provided a Surrender and Quitclaim for the Oil, Gas • and Mineral Lease. CRC is leaving Kern County, and the packet was sent out to all Lessors involved in the lease Surrender and Quitclaim.
- Covid continues to be an issue and staff will continue to follow the appropriate procedures • for avoidance and limitation of exposure as much as possible.
- The District will continue to direct questions and concerns to Kirk and Simas. •
- The Shafter Sump has been cleared of debris and is now draining nicely. The Wasco Irrigation upgrade has begun, and Kern Sprinklers has begun the trenching for the irrigation system.
